MBA Admission 2025 - 2027

The Master of Business Administration (MBA) at IIT Roorkee is a regular residential programme spread over two academic years divided into eight terms. The course structure is designed to impart knowledge of the core management concepts and techniques in the first year and advanced knowledge and practicing skills in the areas of specialization opted by the students in the final year.

3. ADMISSION ELIGIBILITY CRITERIA

(i) Graduation or a professional qualification equivalent to that of University degree recognized by UGC, in any discipline with minimum 60% marks (55% for SC / ST / PwD), in addition a CAT 2024 score is mandatory. Final year students are also eligible to apply. Such candidates, if selected, will be admitted provisionally, provided they complete all requirements for the qualifying degree with minimum percentage and CGPA or its equivalent by the specified date that will be intimated later. The percentage will be considered on the basis of aggregate marks / CGPA awarded in qualifying degree examination.

OR

(ii) IIT graduates (admitted through IIT-JEE) with a CGPA 7.0 or above on 10-point scale are exempted from the requirement of CAT 2024.

4. ADMISSION CATEGORIES

4.1	Regular Candidates
	Final year students of any undergraduate programmes who have completed the requirements of qualifying examination can also apply. In case of non-availability of the marksheet of final examination at the time of the interview due to delay in the announcement of their results, candidates may be allowed to appear in the interview on the basis of their aggregate results upto pre-final year in which the percentage should not be less than as specified in <i>section 3</i> . However, they will be required to submit the proof of having passed the qualifying examination with the required percentage or CGPA at the time of registration.
4.2	Golden Girl Scheme for Female Candidates
	<p>Direct admission for female candidates under “Golden Girl Scheme”</p> <p>a) Eligibility: FIRST Rank holder (Gold Medalist) female candidates in qualifying examination from an IIT and/or Institute/University within the Top 50 ranks (overall category) in the NIRF in the most recent year.</p> <p>b) Relaxation: The requirement of qualifying an All-India Level Exam shall be EXEMPTED. However, all other MEQs will be applicable as per the institute policy.</p> <p>c) Intake: Intake shall be supernumerary.</p> <p>Note: Appearing candidates in the qualifying degree will not be considered under this scheme.</p>
4.3	Full-Time Sponsored Candidates
	The candidates must have a minimum of two years of full-time work experience in responsible capacity in a Registered Firm / Company / Industry / Educational and Research Institution / Govt. / Quasi Govt. / Autonomous Organization in the relevant field in which admission is being sought. The Firm / Company / Industry shall either be a public sector undertaking or a public limited company registered in a stock exchange or a private concern whose annual turnover during the past two years exceeds Five Crores Rupees. The Educational Institution should be recognized by AICTE / UGC / Competent Authority.
4.4	International Candidates
	International candidates who fulfil the eligibility criteria mentioned in <i>section 3</i> may apply as per the procedure given in point 6.1. International candidates who are neither IIT graduates (admitted through IIT-JEE) with a CGPA 7.0 or above on 10 point scale nor having CAT-2024 score, are requested to visit the website of International Relations, IIT Roorkee https://ir.iitr.ac.in/ for relevant information towards application submission, registration, fee structure, accommodation, etc. Admissions of International candidates are processed separately from regular MBA seats.

5. ADMISSION PROCEDURE AND CANCELLATION

5.1	Interview and Group Discussion
	<p>A certain number of candidates shall be called for Group Discussion and Interview. Call letters shall be sent to the shortlisted candidates through email. This list will also be available on the department webpage.</p> <p>Offline interviews are likely to be held at Roorkee, Greater Noida, Mumbai, Bengaluru and Kolkata. Candidates will give their preference of location but venue of interview may be different from the top preference of the applicant.</p>
5.2	Documents required at the time of Interview

5.3	Admission Offer
	<p>Based on the aggregate performance, a merit list shall be drawn for offering provisional admission to the Programme. Provisional admission offers shall be sent by email at the mailing address as given in the application form. This information will also be available on the Institute website.</p> <p>The candidates offered provisional admission should deposit full fee latest by the date specified in the provisional admission offer letter, failing which their candidature for admission may stand cancelled. A system of registration is followed for all the students joining the Institute. The selected candidates will have to register personally as per the schedule.</p>

5.4	Fee Refund
	No refund of fees will be permissible to the students who get registered for the Programme but do not join subsequently or who leave the Programme after joining. In such cases, only security and mess balance will be refunded. Other details, if any, will be published online on IITR website.
5.5	Admission Offer
	Admission process will be completed through multiple rounds of offer, if required. Candidates need to be prepared with the requisite fee and all necessary documents for registration at a short notice. Information will be updated on the website.
5.6	Cancellation of Admission
	The Institute has the right to cancel at any stage, the admission of a candidate who is admitted to a course to which he or she is not entitled being unqualified or ineligible in accordance with the statutes and regulations in force. Disputes, if any, arising out of or relating to any matter whatsoever concerning admissions to the MBA Programme at IITR shall be subject to exclusive jurisdiction of Roorkee.
