### Family Dispute Resolution Clinic (FDRC):

- Sharda School of Law, in collaboration with the Gautam Budh Nagar Police Commissionerate, established the Family Dispute Resolution Clinic (FDRC) at Knowledge Park-2 Police Station, Greater Noida.
- The FDRC provides client-centred and compassionate family dispute resolution services through mediation, primarily assisting couples in reconciling disputes amicably.
- The clinic's multidisciplinary team includes law faculty, psychiatrists, counsellors, researchers, NGOs, and police officials.
- Over the past three and a half years, the FDRC conducted over 4,200 counselling sessions, addressed 1,088 cases, and resolved 400 disputes with a success rate of around 88%.
- By de-escalating conflicts and offering psychological and legal guidance, the FDRC has prevented unnecessary litigation and promoted mutually respectful, satisfactory outcomes.

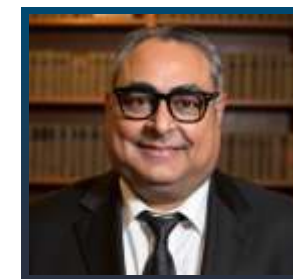
